The European Board for Certification in Facial Plastic and Reconstructive Surgery

Why is EBCFPRS Board Examination and Certification important for you?

The EBCFPRS examination and board certification process is regarded as a global benchmark in Facial Plastic Surgery. A constantly growing number of now more than 80 colleagues have completed the process and are formally recognized as "Board Certified Facial Plastic Surgeons (EBCFPRS)".

Who can apply for the process and are recognized by EBCFPRS as "Board Certified in Facial Plastic Surgery (EBCFPRS)"?

Currently, all European Surgeons Board Certified in Otolaryngology / Head and Neck Surgery or in Plastic Surgery are eligible to certify in one of two ways:

1. The "Regular Track": The candidate is fully board certified; 100 surgical cases (50 per year) are peer reviewed; professional standing is verified; the candidate sits the European Board Exam in London.
2. The "Fellowship Track": The candidate sits the Board Exam after completion of their 12 month fellowship; 100 cases (50 per year) are subsequently peer reviewed.

What are the benefits of EBCFPRS Certification?

The Board Examination is a highly sophisticated process that has involved creation, review, and field testing of hundreds of questions. Biometricians and other specialists are constantly working on testing and improving both the written and the oral protocols in order to ensure that your exam is meaningful, fair and reflects competency.
